Appendix 2: Team Registrar's Report from Simon Argus

Team Managers Report - AGM October 2022

Redcliffe Red Dragons (RRD) had 81 members in the 2021/22 financial year. Only 45 of those members have returned for 2022/23, meaning 36 members (or 44%) did not return. Since July, three (3) new members have joined, giving a current total of 48 RRD Members. Additionally, one paddler is currently on the Dragon Pass.

The 48 RRD members include:

- 6 members who are 70 years old and over;
- 21 members who are between 60 and 69 years of age, comprising 3 male and 18 female members;
- 15 members who are between 50 and 59 years of age. This includes one member who has indicated they may transfer to another club, which will reduce the number in this age category to 14 and the total RRD members to 47. The 14 members in this category comprise 4 male and 10 female members;
- 6 members are under 50 years of age including one male who is a Junior member; and
- The 48 members include 10 Pink Snapdragons, of which only 2 have been recently participating in Regattas.

The 48 members excludes Lyn Stainlay, who as a life member of RRD would normally have her DBQ Fees paid by RRD. However, given she has moved to New South Wales we are waiting to see if she wishes to be involved with RRD this year.

2022/23 Membership Application Forms

I have 37 forms, but there could be a few more added since I have been away. Of those members who regularly attend training, 7 have forms outstanding.

Regattas

Regattas attended since the last General Meeting:

- Cooloola Regatta Tin Can Bay, attended by 26 members, and RRD entered 2 teams; and
- Te Waka Regatta, Lake Kawana, attended by 18 RRD members and 4 Fraser Coast members who paddled with RRD.

Membership for 2023 State and National Competitions

For the purposes of the 2023 State and National Competitions, the club currently has 25 active members, given recent attendance at regattas and training, and registrations for future regattas.

These 25 active members comprise:

- 2 members are in the Senior A category, and therefore are unable to form a crew for RRD;
- 10 members are in the Senior B category, including 2 males; and
- 13 members are in the Senior C category, including 5 males.

The 23 Senior B and Senior C members are potentially available for the State Championships, and the number potentially available for the Nationals would be much less.
