# 4. ANNUAL REPORTS:

## President - Mel Roper

"We had an amazing regatta this year – with thanks to Iciar and helpers for organising this, and thanks to all club members who volunteered. We raised approx. \$11,000.

Fund raising is always very important and next year we're looking to send a team to the Nationals. Fundraising will help towards the cost as this is applied for on an ad hoc basis. Thank you to all those that volunteer their time to help out. It's been great to see new faces. The club has had a 10% increase in membership recently. This is a big thanks to everyone for being welcoming and creating a good club culture".

## Treasurer – Lisa Dunne

Presented the accounts for year ended 2023. The largest income was the Insurance payment following the theft of the safety boat. It is to be noted the recent Regatta income is not included in the accounts. Account filed with minutes.

# Registrar - Simon Argus

There are 52 members this year plus 3 members on a dragon pass. Of paid up members, there are 15 male members and 32 members over the age of 60 years. Although we are an aged club, there is a possibility next year we may be able to have a Senior B team, should the dragon pass members join.

## Coach – Iciar Argus

Iciar reported that some members have been videoed, paddling in the Zonta boat for review of technique. We have a new Concept 2 rowing machine for club use, and it will also be used during land-based training sessions.

Vince is now a Level 3 sweep and she thanked our sweeps – Del, Cheryl, Phil and Vince. Iciar also reported that there will be fitness testing for paddlers wishing to attend States. Report filed with minutes.

# 5. PRESENTATION AND ADOPTION OF AUDITED FINANCIAL STATEMENT:

#### 7. PRESENTATION AND ADOPTION OF NEW CONSTITUTION:

New Constitution provided by CPR Group on behalf of DBQ for use by all QLD dragon boat clubs. RRD personalised the membership section for additional class of Associate member.

Simon did not agree with wording in the Objectives of the Club that included outrigging and other paddle sports and that on winding up of the club our assets could be given to Outrigging clubs who do not have the same objectives. Mel said this future proofed the club for any change in circumstances. All assets at time of the club ceasing will be dealt with by the committee and will require club members approval at an AGM/General Meeting.

Motion: That RRD adopts its proposed new constitution as the constitution of the club.

## 8. PRESENTATION AND ADOPTION OF RRD CLUB STRATEGY 2023-2026

Motion: That RRD adopts the updated Club Strategy 2023 – 2026

# 9. DISCOUNTED MEMBERSHIP:

Motion: That RRD club coaches and sweeps get 25% discount on annual club fees, and Associated member get 50% discount on club fees.

## Discussion:

It was noted in the Constitution that the Committee decided the annual fees. It was stated any increase will continue to be put to club members for approval at a General Meeting.

Unanimous decision for 25% discount for sweeps and coaches.

Some members felt 50% fee for Associate member too high as this is a non-paddling membership – however this membership comes with voting rights and 25% fee was proposed.

Club insurance will cover Associate member and volunteers.
